If either form of entry has not filled at the end of the 48 hour time period, the club reserves the right to decrease or increase either the online or paper limits accordingly. Paper entries received within the first 24 hours must include postage or be metered. Check-in will begin at 7:00 AM, first dog on the line at 8:00 AM MT. Crates may be set up Friday, November 29, 2019 after 7:00 am. No set ups on the arena floor until after the ring set up is completed.

**Dogs may arrive** any time prior to judging. Dogs that need to be measured must be available for measuring prior to the start of their class. All dogs not needed for further judging will be excused.

**Judges are not required** to wait for dogs. They will adhere as closely as possible to the judging schedule. The owner or handler of each dog is solely responsible for having it ready at ringside when it is to be judged. Neither the club nor the Trial Secretary have any obligation or responsibility to provide a service through a public address system, or stewards, or runners, for the purpose of calling or locating dogs that are not brought into the ring when required.

Running Order Conflicts: The trial secretary will make every effort to minimize running order conflicts for a handler running two or more dogs in the same class and height, or in adjacent heights. On the day of a trial, if a handler feels more separation is needed, the club will make every effort to accommodate the request. When more separation is requested, per AKC rule, the judge must be asked to grant the change. The trial chair or gate steward may make the request on the handler's behalf. There are likely very few instances where the request will not be granted. Please note that, also per AKC rule, the second dog may be moved down in the order, but the first dog may not be moved up. Out of consideration for affected competitors, the scribe and the scorer, the club asks that all running order change requests be made no later than before the start of the briefing for the class in question.

\*\*\* **FAST** will be a nested course with one walk thru for all levels. All FAST classes will run together grouped by jump height. ## COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only.

A warm-up area, consisting of a regulation agility jump, will be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

## Measuring and Height Card Information

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Furthermore, this change eliminates the need for a copy of the jump height card to be submitted with an entry form. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the Judge of Record PRIOR to running in their class and this measurement will be valid for that weekend of trials only. If a Volunteer Measuring Official (VMO) or an Agility Field Rep is present; ALL dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog before its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

## **NEW Simplified Jump Height Card Process**

When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog needs to be officially measured. Please check the box so that the Trial Secretary knows whether to include your dog on the Dogs to Be Measured List.

#### Dogs Eligible to Enter

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes. Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible and neither are aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four months of age are strictly prohibited from the trial grounds.

After the close of entries, a dog, which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler, may be moved to the Novice "B" class. A request must be submitted to the trial secretary at least 30 minutes prior to the start of EACH trial and must state the reason and justification for the move. A dog may be moved down in their class level (i.e., Master to Excellent). The request for the move to the class for which the dog is eligible must be in writing and submitted to the superintendent or trial secretary at least 30 minutes prior to the start of the trial. (Chapter 1 Section 21)

All dogs must be on leash at all times or otherwise confined when on trial/show grounds except when in the designated warm-up area or competing on the course. (AKC leash restrictions March 2009, Utah leash law/code 6.16.080)). Trial grounds are defined as the entire public interior area of the Legacy Center as well as the grassy area immediately adjacent to the building, north of the parking lot A, west of the building, south of parking lot B. There is a fenced dog park area south of the 3 smaller buildings.

**Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. #### INSTRUCTIONS

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine Partners<sup>SM</sup> program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
